Dubai businesses more upbeat on improving market conditions

With the Expo 2020 and a big surge in the inflow of tourists expected to revitalise commercial activity, businesses in Dubai are getting more upbeat on improving market conditions and strong prospects for international reach, Dubai Economy said.

The quarterly survey of Dubai Economy showed that the proportion of firms anticipating improvement in business situation in the first quarter of 2020 has increased to 60 per cent, from 58 per cent for the previous quarter, with the Expo 2020 and tourist arrivals expected to energise commercial activity.

In a statement, Dubai Economy said while softer demand, lower margins and less projects have had an impact in the last quarter of 2019 when 19 per cent businesses rated their performance as below par, the first quarter of 2020 is expected to bring in new purchase orders, increased volumes and more jobs.

Dubai: A sprawling new Hindu temple will come up in Jebel Ali in Dubai by early 2022, *Gulf News* can reveal.

UAE economy grew at 2.9% in 2019, says central bank

The UAE economy grew by 2.9 per cent in 2019 as compared to 1.7 per cent in the previous year, mainly driven by growth in the oil sector, the Central Bank said in its fourth-quarter report.

"The overall real GDP is estimated to have grown by 2.9 per cent in 2019, driven by the growth in the non-hydrocarbon sector - estimated at 1.1 per cent and by the hydrocarbon sector for which growth is estimated at 7.6 per cent in 2019. The hydrocarbon sector exhibited significant growth, mainly due to the two-digit growth in condensates and natural gas production," the Central Bank said in the report.





How 100% Dubai traffic fine discount scheme helped UAE residents




As Dubai's 100 per cent traffic fine discount scheme ends today, residents who were given a respite from paying 'massive fines' called the scheme a 'blessing'.

According to a brief release issued, the Dubai Police reminded motorists that Thursday was the last day to avail of the year-long discount scheme that offered up to 100 per cent waiver on traffic fines.

The scheme was launched on February 7, 2019, a first-of-its-type initiative, according to which motorists who did not commit any violations for three months could get a 25 per cent discount on their fines.

Furthermore, no violations for six months would entitle them to a 50 per cent discount. Keep driving well for nine months and you could get a 75 per cent discount and 100 per cent discount if you didn't commit any violation in a year.





Abu Dhabi: The Federal Tax Authority, FTA, launched the "Basic Tax Information Bulletin" as part of its campaign for 2020, as it seeks to continue raising awareness about taxes and providing taxpayers with periodic and detailed tax information.

In its first edition, the bulletin focuses on tax treatment for the education sector, including schools, pre-schools, and nurseries.

Latest UAE fuel prices: March 2020



The Ministry of Energy and Industry on Thursday announced fuel prices for the month of March, with prices set to go down compared to February.

The per-litre prices are Super 98 at 2.16, down from Dh2.24 last month and Special 95 at Dh2.04, also down from Dh2.12 in February. E PLus 91 will be priced at Dh1.97 per litre.

Diesel prices are at Dh2.25 down from Dh2.40 per litre.

Global prices have gone down, Reuters reported on Wednesday. US crude dropped below \$50, the lowest level since January 2019, as Asia, Europe and oil producing countries in the Middle East reported hundreds of new coronavirus cases and the United States warned of an inevitable pandemic.
